Safe traffic management systems will operate during site building (early morning Thursday 21 June) and site take down (early morning Sunday 24 June). Park closures will be kept to a minimum but some park closures will be necessary for public safety.

FRIDAY 22 JUNE 2018

Re-opening at 2pm.

8am: Park closed to the public. Entrance for vendors and performers only.
11am-2pm: Park is open to the public- Family Event
2pm: Park is closed to the public.
6.30pm: Park is open for the People's Concert (Ticket holders only). Entrance through Magheralave and Belfast Road gates only
7pm-9.30pm: The People's Concert

SUNDAY 24 JUNE 2018

Park is re-opened to the public and a traffic management system will operate during remainder stage take-down.

SHARED SPACE

- Lisburn and Castlereagh City Council (the Council) request that patrons assist in creating a shared event space. It reserves the right to restrict access to events if it is deemed by the Council that a patron(s) is/are in breach of this position. The Council also has a duty to ensure equality rights are protected under Section 75 of the Northern Ireland Act and reserves the right to restrict access to events should a patron behave in a way that is likely to constitute a breach of these obligations.
- Flags, emblems or other paraphernalia of a political, sectarian, racial or partisan nature will not be permitted on site.
